

## Avalara NEXT 2026 Giveaway Terms and Conditions

**NO PURCHASE NECESSARY. VOID WHERE PROHIBITED. ODDS OF WINNING DEPEND ON NUMBER OF ENTRIES RECEIVED.**

This Event Giveaway (the "Giveaway") is sponsored by Avalara, Inc. ("**Avalara**"), 512 Mangum Street, Suite 100, Durham, NC 27701. By participating in the Giveaway, you hereby agree to be bound by and comply with these terms and conditions (the "**Terms**"), and to comply with Avalara's decisions in connection with this Giveaway, which are final and binding.
