States such as California are expanding environmental surcharges, including e-waste recovery fees, that apply to communications equipment, devices, and bundled services.



# Common compliance pitfalls that increase audit risk

#### **ZIP-CODE SOURCING ERRORS**

Relying on postal codes instead of precise location leads to misapplied taxes.



#### **MISCLASSIFYING SERVICES**

Digital versus telecom versus bundled offerings often get taxed incorrectly.



#### LAPSED EXEMPTION CERTIFICATES

Expired, missing, or poorly tracked documents trigger audit findings.



#### **UNCLEAR INVOICES**

Mixing taxes and surcharges confuses customers and raises compliance flags.



#### **MANUAL FORM 499 AND FEE FILINGS**

Broken workflows for USF, E911, or other filings increase error risk.



#### **ENVIRONMENTAL FEE MISCLASSIFICATION**

As new state-level e-waste and sustainability surcharges take effect, misreporting or omitting them from invoices can create exposure under both environmental and communications tax audits.


